#### **Background**

Although the budget process doesn't require detailed consideration until November, it is beneficial and often necessary for the Events team to begin their planning well in advance. The Council has developed a number of popular and well-branded family events, but the committee is empowered to direct and develop these in any way it sees fit.

#### 10. Jane Pit Miners' Memorial

To receive a brief verbal update on the Heritage Lottery Funded project to establish a memorial to the Mineworkers of Workington at Jane Pit.

#### 11. Black Sabbath Plaque

To consider the suggestion from a member of the public that the Council funds a plaque on the wall at Banklands church rooms to commemorate the gig by the rock band "Earth", in August 1968, at which the band announced its intention to change its name to "Black Sabbath".

## **Background**

Black Sabbath sold over 70 million records worldwide and were described by Rolling Stone magazine as the 'Beatles of Heavy Metal'. Their 1970 album 'Paranoid' is considered to be the founding stone of the musical genre. Although their origins were in the Black Country, the band spent a lot of their formative years playing in and around north Cumberland. They played gigs at Banklands Youth Club and Westfield Welfare under a variety of names such as the "Polka Tulk Blues Band" and "Earth". It is claimed by several people who attended the Banklands gig on 26 August 1969 that Ozzy Osbourne announced the bands new name during the gig. The first billed gig as Black Sabbath was 22 September 1968 at Henry's Blues House in Birmingham. Banklands Youth Club occupied a building, which has since been renovated and upgraded, on the Banklands site.
