# 19.58. Planning Committee

A query was raised concerning a planning application for the change of use of a convenience store on Vulcan Lane to building. The Clerk explained the Council's response to the initial application was based on fairly limited information and reflected their view that material planning grounds for objection were difficult to identify. Subsequently residents had raised a wide range of queries about the application, which were not necessarily planning related, but had been notified to the Planning Authority.

#### 19.60. Environment Committee

A query related to the issue of frontagers being liable for back lanes that were not adopted by Cumbria County Council. It was observed that Gray Street back lane is mostly fronted to the east by Allerdale Borough Councils Central Way Car Park. A Councillor queried whether there was any realistic expectation that Allerdale might contribute. The Chair reported that the Council would write to them and ask. A member asked whether the new Bus Shelter at Salterbeck Cemetery had been cancelled. The Clerk reported that the Council had recently received a donation of £500 from Salterbeck Residents Association for the shelter, and that following a review of alternative supply options, it was back on the agenda for next meeting of the Committee in its original form. A Councillor asked what meetings had been held between the Council and the Vulcan Park Bowling Club. The Chair reported that the Council was liaising with the Club over meeting dates in the coming months.
