P19.34 Apologies

P19.35 Declarations of Interest

The Chair brought the meetings attention to his interest in item 5 and 6, 2) in so far as they related to his employer, persimmon Homes Ltd.

P19.36 Exclusion of Press and Public (Public Bodies Admission to Meetings Act 1960) No issues were raised.

P19.37 Minutes of the last meeting

The Committee received the minutes of the meeting on 4 November 2019 and affirmed them as a true record.

P19.38. Cumbria Coastal Strategy

The Committee considered a consultation document from Cumbria County Council on the Cumbria Coastal Strategy. The Committee focussed their attention on the sections between Harrington Parks (11e2.6) to Risehow (11e3.2). There was some discussion about the likely impact of Climate Change led sea level rise, and how that might have an effect on the type and extent of coastal erosion. There was uncertainty about how several of the Hold the Line areas would be paid for, and what the actual plan was for investigating likely or possible contamination in the timescales

which would be speeded by Climate Change. There was concern about the extent of explanation and consultation with the community, especially for managed retreat at Siddick. There was uncertainty about what the Derwent Howe element actually meant, since Cumbria County Council as landowners had not enforced the Planning Conditions for remediation on the quarry. It was asked that a member of the Coastal Strategy team come and talk to the Town Council to explain several items, as drop in sessions in Whitehaven were not sufficient.

Resolved: To pass this feedback to the County Council.
