**Background**

Traditionally the Harrington Marina Day was a fund raising event. In its new guise it has been suggested that some of this tradition is revived. The Council receives pitch fees from commercial stall holders of around £25 and expects between ten and 15 stall holders. The Committee may decide to redistribute all this to Mayoral Charities, a percentage, or not at all.
